EXECUTIVE ORDER OF BUSINESS:

Mary Simcox presented the January Meetings for DeKalb County Economic Development Jan 14, 2026, New years welcomed two new board members, Chris Garr, at Large for Finance and Kellen Dolley, DeKalb County Commissioner. The board has 15 members, 10 are appointed by County Council, City and Town officials and five are appointed by the Economic Board. Quality of Place Project-Land Restoration-Mary updated Simon of Blue Harron that the 3rd street enhancement will be delayed 2026. This should allow Blue Harron to follow their original timeline. The Jefferson bank erosion information provided the Board last December will be updated with detail elimination process. The plan is being developed for Spring operation. DeKalb County Trails, Inc. – Auburn Station didn't have any meetings.


Randy Drake updated that there are 3 sewer cap residents he plans to get a hold of yet.


ADJOURN:

Misty Spicer made a motion to adjourn the meeting at 8:02pm. Zebulon Griggs seconded the motion. All ayes cast.


