**EXECUTIVE ORDER OF BUSINESS:**

116 Harrison St. Would like to know if the Town has an interdepartmental agreement with the Sheriff department to enforce the ordinances. Their neighbor has been parking a Tow Truck right on the corner, and it is blocking the site of the turn and endangering the local children playing. Erik Webber suggested calling the police about Indiana code 9-21-16-2 Sec. 2. A person who stops, parks, or leaves a vehicle shall leave a sufficient unobstructed width of the roadway opposite the vehicle for the free passage of other vehicles and a clear view of the stopped vehicle from a distance of two hundred (200) feet in each direction upon the highway.

Where they're too close to the intersection and when we, I wasn't here at the time, but this office was, you know, began being filled with the Sheriff's Department, the understanding that we had is that. That there was a local agreement in which we handed them all of our ordinances, and they enforced them for us, but we're being told now that they can't enforce them without an agreement. Zebulon Griggs stated do you know about the validity of that validity of that statement or if in their absence is it the town board or do we need a town Marshall to enforce those? You're talking about civil ordinances that would involve issuing fines, draft ordinance. But it's a town ordinance and it doesn't fine it. Yes, the county is has never ever enforce ordinances of the town. Through the Sheriff's Department. Is that an agreement we could make with them or is that an agreement they were doing it previously when we had the issue and stuff they were following citing for the ordinance violations. If they're willing to do that. It was part of the... We have an interlocal agreement that that they would be willing to do that and yes, that that would be possible. But it depends on what also what things you want them to enforce. It's a safety violation. Is that something that they wouldn't do either? I think you could call. I think that's a violation of Indiana code. You could call the Sheriff's Department and report them. They could write a ticket for that. Zebulon Griggs came across the Indiana code that the Town must have a Town Marshal and would budget putting one on the payroll. Angela suggested using Lit funds for that position.

The next board meeting for December 2<sup>nd</sup> was canceled.


ADJOURN:
