Randy Drake made a motion to adjourn the meeting at 8:05pm. Misty Spicer seconded the motion. All ayes cast.

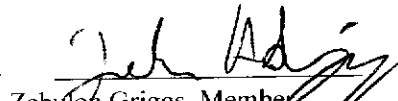
